

Pastoral Meditation: Whatever!!

Whatever!! How many times have we heard this word used in conversations? It may be used sarcastically in the sense that we really don't believe what the person is telling us. *Whatever!!* It may also be used in frustration in the sense that we're tired of arguing with another person. We give up trying to get that person to understand or accept what we're saying, throw up our hands and say

Whatever! It can also express apathy or indifference in the midst of a decision making process. We may have no opinion about the subject one way or another. The concept is: *Whatever. It doesn't make any difference to me!*

Yet, an indifferent attitude can be rather deceiving. While it may appear that a person 'doesn't care', it is really the opposite. They do 'care'... its just that they 'care' only about the things that are important to them. They simply may not 'care' about what's important to someone else. Usually when we encounter the statement *Whatever!!* it leaves us with the feeling that this person doesn't care to listen to what's important to us! We are left with a feeling of rejection. While there may be many things toward which we are indifferent, this attitude is very dangerous when it comes to our relationship with the Lord. Jesus encountered a *Whatever!!* attitude from people many times throughout His earthly ministry. From outright rejection of His Person and Work to indifference toward Him all together, Jesus encountered many people who did not want to receive God's will for their lives deliverance from sin!! John 1:11 says: *"He came to His own, and His own people did not receive Him."* Jesus could have very legitimately walked away from people, thrown up His hands and said *Whatever!!*

However, Jesus did not do this, did He? He came to be right where we are in the mess and muddle of our sin, so much so that, even though He wasn't sinful, He took all our sin upon Himself that in Him we might become the righteousness of God!! He did it so that we could have a new perspective on life as God's children!!! John 1:12 goes on to say: "But to all who did receive Him, who believed in His name, He gave the right to become children of God, who were born, not of blood nor of the will of the flesh nor of the will of man, but of God."

Whatever' in God's vocabulary has a whole different focus: *"Finally, brothers, whatever is true, whatever is honorable, whatever is just, whatever is pure, whatever is lovely, whatever is commendable, if there is any excellence, if there is anything worthy of praise, think about these things . . . and the God of peace will be with you.* "(cf. Philippians 4:8,9b) All of these **'whatevers'** find their definition in Jesus Christ. When we meet Jesus right where we are with repentance of our sin we take Jesus everywhere we go as His renewed people ready to make an impact upon our world!!

So when it comes to Jesus, God does not respond with *Whatever!* in some sarcastic, negative way of rejection. Rather, He responds to us by saying: '*Whatever* you have done, it is forgiven! *Whatever* you do, I will give you strength! *Whatever* you need, I will provide! *Whatever* needs to happen in your life, I have provided in Jesus!!' God is not indifferent toward us! By His grace through Jesus we too are not indifferent toward Him! We appreciate His Word and Work in Christ and desire to follow Him in every area of our lives, right where we are!! — Pastor Dave Suelzle, ND District LWML Junior Counselor

2012 Convention Speaker Snapshots

KEYNOTE Speaker, Nabil Subhi Nour, 56, is a naturalized U.S. citizen; however, he grew up in Nazareth, Israel where many family members still reside. He is a



Palestinian by nationality, and came to the U.S. at the age of 16 with no English skills.He entered the 11th grade at Huron High School in South Dakota. He continued his education at Huron College (now Huron University) and graduated in 1979 with a B. S. degree in

criminology and sociology, with minors in psychology and gerontology. In 1977, he married Jean Marie Miedema of Hitchcock, S.D Into this marriage three lovely sons were given.

After converting to Lutheranism, he received encouragement to consider the pastoral office from his fellow church members and pastor. In 1989, he entered Concordia Theological Seminary in St. Louis, MO and graduated in 1994. He is now a servant of the most High God and Lord, in His vineyard at Armour, South Dakota; he is also continuing his studies from CTS.

ND Full-time Church Worker Scholarships Grant Proposed New Standing Rule

(Approved by LWML ND Board of Directors on 11/12/11 to be approved by 2012 delegates.)

The ND Full-time Church Worker Scholarships Grant will receive funding of \$35,000 every biennium and will be placed at the top of the funding schedule. (The remaining grants as voted at convention will be placed on the funding schedule below the ND Full-time Church Worker Scholarships in the order of votes received. Total monies for their funding will be the mite goal less the \$35,000.)

Rationale: We have funded the ND Church Worker Scholarships since 1980. We are the main contributor to this fund and would not like it to be in jeopardy if delegates would assume it will be voted in and then vote for other projects. We would like it to always be at the top of the funding schedule.

MISSION GRANT PROPOSALS 2012-2014

MG 801--\$5,000

Catechisms for the Chinese

(Lutheran Heritage Foundation)

Goal: To print and distribute *Luther's Small Catechism with Explanation*, a side-by-side Chinese/English catechism,

providing churches and missionaries with the tools they need to spread the Gospel to the Chinese.

WHEREAS, the Holy Spirit at Pentecost gave Jesus' disciples the gift of speaking in many tongues so that all God's children might hear His call (Acts 2:1-41); and

WHEREAS, the LCMS already has more than 30 pastors who reach out to Chinese, as well as many established Chinese ministries both nationally and internationally, including the North Dakota District; and

WHEREAS, Lutheran Chinese missionaries and church leaders have expressed a deep need for Lutheran materials printed in the native language of the people they serve; and

WHEREAS, the Lutheran Heritage Foundation, a recognized service organization of the LCMS, has for 20 years vigorously fulfilled its mission of translating and publishing Lutheran books, such as *Luther's Small Catechism* and *A Child's Garden of Bible Stories* into the languages of the world; and

WHEREAS, the Lutheran Heritage Foundation has received more than 100 requests for Chinese-language catechisms, including some from pastors in North Dakota;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$5,000 to the Lutheran Heritage Foundation to publish and distribute Catechism for the Chinese.

MG 802--\$7,500

Orphan Grain Train-North Dakota

Goal: To provide food, clothing, medical supplies and God's Word to those in need who have suffered losses in floods, droughts, hurricanes and fires in the U.S. and also to help the destitute people of Mexico, Russia, Latvia, China and Liberia.

WHEREAS, the Orphan Grain Train was born over nineteen years ago in loving response to Christ, the Servant, to encourage and enable God's people to share personal and material resources in bringing Christ's name and character to needy people both far and near; and

WHEREAS, many thousands of Christians have joined in this great endeavor—there are now nineteen branches across the US, sending to date over 1,862 twenty ton containers to 49 countries around the world valued at well over \$75 million and representing over three million hours of work donated by volunteers; over forty of these containers have been sent from ND; and

WHEREAS, the OGT is meeting the needs of destitute people in Russia, Latvia, Liberia, Mexico and other countries around the world and also hurricane, flood, tornado and fire victims in the US who have suffered great losses of life; and especially flood victims in Bismarck and Minot, ND who have faced the loss of homes and business; and

WHEREAS, Rev. Sam Freeman has established a ministry around Monrovia, Liberia, bringing the Gospel of our Lord Jesus Christ through worship, two Christian schools, a clinic and an orphanage, as well as supplying material resources for the people's physical needs; and

WHEREAS, the efforts of the OGT continue by giving gifts of food, clothing, medical supplies and God's Word to those in need;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$7,500 for the work of the Orphan Grain Train—ND Branch; and

BE IT FURTHER RESOLVED that the ladies of the ND LWML continue to support the ministry of the OGT with their personal involvement and fervent prayers so that the Gospel of our Lord Jesus Christ may be spread in word and deed throughout the world.

MG 804--\$2,000

Encountering Christ through Scripture—Helping Women of Liberia, West Africa Learn to Read

Goal: To train staff and supply classrooms for literacy learning centers and thus open a window of opportunity for Liberian women to explore the Good News found in Scripture, strengthening the faith of believers and leading others to faith as followers of Jesus Christ.

WHEREAS, the Great Commission of our Lord and Savior Jesus Christ commands us to reach out to all nations; and WHEREAS, Lutheran Bible Translators is the only Lutheran organization whose purpose is to help bring people to faith in Jesus Christ by making the Word of God available to those who do not yet have it in the language of their hearts; and

WHEREAS, Lutheran Bible Translators is a recognized service organization of the LCMS; and

WHEREAS, Lutheran Bible Translators works in partnership with and under the sponsorship of Lutheran organizations around the world and especially with the LCMS World Mission; and

WHEREAS, through literacy programs, LBT provides women with the education needed to be able to read Scripture in their mother tongue;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$2,000 to Lutheran Bible Translators for the "Encountering Christ through Scripture—Helping Women of Liberia, West Africa Learn to Read" program.

MG 805--\$5,000

Restoring Security for His Children—Minot Dakota Boys & Girls Ranch

Goal: To restore each living unit on the Minot Campus after the Historic Flood of 2011 to allow at-risk youth a safe and secure living environment.

WHEREAS, God instructs us to "train a child in the way he should go, and when he is old he will not turn from it" (Proverbs 22:6); and

WHEREAS, Dakota Boys and Girls Ranch is a necessary mission field and has children from across North Dakota; and

WHEREAS, the physical, mental and spiritual care of the youth are the mission of DBGR; and

WHEREAS, DBGR must rebuild the housing to provide a space to care for and help these at-risk youth as they work on issues challenging them in daily living and provide for their spiritual well-being;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$5,000 to Restoring Security for His Children—Minot Dakota Boys and Girls Ranch Campus.

MG 806--\$5,000

Christ the Way Radio Ministry

Goal: To share the Gospel of Jesus Christ in North Dakota, South Dakota, Minnesota and other states through a 15-minute radio message every Sunday morning.

WHEREAS, Christ the Way is a ND District radio ministry that has aired for over 20 years; and

WHEREAS, Christ the Way is a unique radio program in that the messages are given exclusively by LCMS pastors of the ND District; and

WHEREAS, Christ the Way proclaims the Gospel of Jesus Christ to people in a five state region; and

WHEREAS, the fund established years ago to support Christ the Way has been used up and it costs \$55 to air a 15-minute message each Sunday, so approximately \$2800 each year;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$5,000 to Christ the Way Radio Ministry.

MG 807-\$35,000

ND Full-time Church Workers' Scholarships

Goal: To aid ND students with the financial costs associated with attending schools, colleges and seminaries in order that they may train to become full-time church workers.

WHEREAS, North Dakota youth and adults who desire to be educated and become full-time workers in God's kingdom in the LCMS should be encouraged and aided as they serve the Lord; and

WHEREAS, Christ, in His Holy Word, has commanded us to go into all the world to teach and proclaim His message of salvation; and

WHEREAS, the cost of higher education continues to escalate and become a financial burden for those students; and

WHEREAS, students from North Dakota attending LCMS universities and seminaries to train for full-time church work will share the money from this grant;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$35,000 to the North Dakota LCMS District for ND Full-time Church Workers' Scholarships.

MG 809--\$2,000

Carolyn Walsh, Lutheran Bible Translator Missionary to Botswana, Africa

Goal: To assist with the expenses of Carolyn Walsh's trip and two year internship with Lutheran Bible Translators in Botswana, Africa.

WHEREAS, Jesus commands us to go into all the world and preach the Gospel to everyone, and the harvest is plentiful, but the workers are few; and

WHEREAS, there are LCMS missionaries and Lutheran Bible Translators already in Botswana; and

WHEREAS, Carolyn Walsh, a member of Grace Lutheran Church in Fargo, has been trained at Concordia University, St. Paul and is doing her two-year internship in Botswana to complete her degree in the Director of Christian Outreach Program; and

WHEREAS, air transportation is expensive along with two years living expenses totaling approximately \$30,000 and Carolyn does not receive funding, but must pay her own expenses;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$2,000 to Lutheran Bible Translators for Carolyn Walsh.

MG 811--\$5,000

Holy Cross Lutheran of Bismarck Kitchen Project

Goal: To furnish and equip the kitchen in our newly renovated church building in north Bismarck.

WHEREAS, Christ in His Holy Word has directed us to bring people to know him; and

WHEREAS, Holy Cross Lutheran Church of Bismarck is a necessary mission field in a new neighborhood and has already drawn new members to the LCMS church; and

WHEREAS, fellowship and community service events such as the Red Cross providing meals to the less fortunate in the community are an important element in the church; and

WHEREAS, kitchen equipment and furnishings to code are needed to complete our renovated mission church;

THEREFORE BE IT RESOLVED that the 2012 Convention of the ND LWML grant \$5,000 to the Holy Cross Lutheran Kitchen Project.

MG 812--\$4,000

Production of Large-Print Scripture Calendars and Large-Type *Quarterlies* and Supplies--Lutheran Blind Mission

Goal: To assist the work center at Zion Lutheran Church in New Salem, ND with purchasing the supplies needed to produce large-type materials for Lutheran Blind Mission and thus helping the blind and visually-impaired people see Jesus.

WHEREAS, the Great Commission of our Lord and Savior Jesus Christ commands us to reach out to all at home and abroad; and

unique in that the founders of this project are from North Dakota and Minnesota, namely Roger Weinlaeder, Rev. Bernie Seter, Bill Sharpe, Bob Wurl, Ed Bean, Mark Hatloy and Kurt Daudt. They travel to Kenya frequently to provide accountability and personal contact; and

WHEREAS, the number of children in Kenya needing aid far exceeds the number of rescue centers available;




